Fisterra Gardens is a 25 unit tax credit housing rental property located in the City of Yachats on a 1.21 acre parcel of land north of the existing Sea-Aire Assisted Living Center and east of Highway 101.

Households must be income eligible to be qualified to live at Fisterra Gardens. The minimum monthly income required is one and a half times the monthly rent. The total household annual income must not exceed the limit below for the household size. (60% of HUD determined Median Income)

## **DISCRIMINATION**

- Signatures (18 years and older)
- Social Security Numbers all household members
- Declaration of Immigration Status

**PLEASE NOTE:** In order to for your application to be considered completed, you will be required to provide copies of the following for each household member:

- Copies of Social Security Card (necessary for criminal screening and employment verification) all household members and picture identification (18 years and older)
- Proof of income (SS award letter, pension, employment, etc.)
- Complete name and mailing address for all landlord and personal references
- Documentation of Assets, including copies of bank statements for the last six (6) months

**MISREPRESENTATION ON THE APPLICATION OR TENANT CERTIFICATION:** In making application for Fistera Gardens Apartments housing, information supplied in the application and certification process or after being leased is considered material and that a violation of any obligation or misrepresentation of any information shall constitute a breach of the application and any lease entered into with the applicant.
